# REVIEW OF WORK DONE BY GEOLOGICAL SURVEY OF INDIA (GSI) CENTRAL REGION NAGPUR AND PROPOSALS

Shri M.M Powar, GSI, gave brief account of the work carried out by GSI during field season 2018-19 in the State under various missions. The different missions are:

**Mission** – **I** : Baseline Geo Science Data Generation.

Mission - II: Natural Resource Assessment

Mission - IIA: Mineral Resource Assessment

**Mission – IV**: Multidisciplinary and Fundamental Geosciences. Earth quake geology, Engineering Geology, landslide, and volcanology.

**Mission –V**: Training and Capacity Building.

Mr. Powar suggested that during next F.S.P. GSI will proposed projects in the State which will be taken up in co-ordination with the State Government in order to train the officials of the State Govt.

The Chairman enquired Mr. Powar about the industrial application & chances of commercial exploitation of pegmatite, rare earth & basemetal minerals. In reply to this Mr. Powar informed the house that these minerals are of commercial importance & the geological reports of these prospecting work has already been handed over to State Government for auctioning.

Mr. Powar further rendered presentation on Earthquake Geology, Engineering Geology & Landslide studies being carried out in the state. The Chairman then asked whether the findings of these studies are shared with State Government. In response to this Mr. Powar told that District Authorities of Raigad & Pune have already been informed regarding landslide zones and suggested remedial measures to be taken. He further informed the house that details of these information are available on GSI portal.

# 55.5.4 <u>REVIEW OF WORK DONE BY MINERAL EXPLORATION</u> CORPORATION LIMITED (MECL) AND PROPOSALS

Shri Pradeep Kulkarni, Sr. Manager (Geology) of Mineral Exploration Corporation Ltd. presented the work done by MECL for coal during field season 2018-19 in Chikhaldhokra block Bander coal field area Dahegaon-Dhapewada block Katol Basin Member secretary enquired whether CBM-Coal Bed Methane studies has been carried out in Chikhaldhokra block. In reply to this Mr. Kulkarni told that no such studies are carried out during exploration and Mr. Kulkarni then informed the house about the exploration work don under NMET in Pathri-Saoli Block in Chandrapur dist., Aurala-Saoli Block in Nanded dist. Dhanori-Bazar Block in Shindhudurg dist. for PGE. (Ba, Au, Pb, Cu and W) (Fe, Ni,Cr, PGE Al Au) respectively and the Reconnaissance survey (G4) for assessment of Tungsten mineralisation in Kuhi-Khobna-Agargaon gap area Mr. Powar asked whether it is same area already explored by GSI previously. Mr. Kulkarni replied that it is actually the gap area between the already explored area. Mr. Powar further told that the ultramafic rocks in the Dhanoli area of Sindhudurg district are promising for basemetals & asked whether MECL has taken up drilling in this area. In reply to this, Mr. Kulkarni said that this area is ecosensitive area& that drilling could not be done. Then he requested Member Secretary SGPB to give Consent for G2 level exploration in Minjhari and Bamni Copper Block to be taken up by MECL. The G3 level of exploration in this area is carried out by GSI. The Member Secretary informed that the decision would be taken consultation with the State Government. [Action DGM]

### 55.5.5 PRESENTATION BY IBM

Shri Abhay Agrawal Regional Controller of Mines of IBM presented brief account of work carried out by IBM during 2018-19 which includes inspection of mines for enforcement of MCDR-2017 .Approval of mining plans, review of mining plan, final mine-closure plan under MCDR- 2017 and MCR-2016.

Mines Environment and mineral conservation week celebrated and Swaccha Bharat Mission Observed.

Then he presented programme for 2019-20 which include inspection of mines follow up of MCDR-2017, site inspection for disposal of mining plan/MMP/RMP and PMCP/FMCP, site inspection of mines for star Rating and mines Environment of mineral conservation week.

He requested State Government to update NMET portal regularly or the handmade information may be submitted regularly. [Action DGM]

# 55.5.6 <u>CMPDIL</u>: <u>REVIEW OF WORK DONE BY CMPDIL AND PROPOSALS</u>

Shri M. K. Reddy, General Manager HOD (EXP.) CMPDI submitted brief account of work carried out in areas of Wardha Valley Coal Field and during field season 2018-19 total 9648.50 mts. of drilling completed by the department and outsourcing agencies during 2018-19. He also submitted work proposed to be carried out by CMPDIL during ensuing field season – 2019-20.

### 55.5.7 PRESENTATION BY AMD

Shri Suresh Kumar, Regional Director, AMD informed Board about the contact core drilling to probe the subsurface continuity of proterozoic unconformity /sandstone type Uranium mineralization in kolarbhatti, makardhokda area of Gondia district and Reconnaissance radiometrict survey and geological mapping covering an area of 365 sq.km (1:50,000) for proterozoic unconformity / sandstone type of uranium mineralization in Bijepar—Salitola-Basghnadi area of Gondia district. Further he informed work taken up in field season 2018-19 would continued for the field season 2019-20.

#### 55.5.8 PRESENTATION BY MRSAC

Dr. Ajay Deshpande MRSAC, presented the work carried out by MRSAC in 2018-19.He informed the board that they have completed task for database generation for major minerals in the state. MRSAC prepared a comprehensive document "MAHABHUSAMPADA" for generation of remote sensing and GIS database pertaining to the minor minerals. MahaDMP, MahaMINERALS, MahaSAND developed by MRSAC for various activities under MahaGEOMIN project.

### 55.5.9 REVIEW OF WORK DONE & PROPOSALS BY MOIL

Dr. S. K. Sarkar Chief Manager (Geology) presented work carried out by MOIL in Chikla, Gumgaon and Parsoda, Kandri, Dongri Buzurg lease areas of Bhandara and Nagpur district during 2018-19 and presented work proposed to be carried out by MOIL during ensuing field season 2019-20 in mines located in Nagpur and Bhandara district.

### 55.5.10 <u>DIGITIZATION OF REPORTS FOR NGDR</u>

Mr. Powar, DDG GSI informed the house that the National Geoscience Data Repository (NGDR) project was conceptualized by Ministry of Mines as a part of National Mineral Policy NMEP & has been set up by GSI as a part of series of measures for accelerating mineral exploration activities. Further he requested to share the digitized data with NGDR for sharing in public domain. Member Secretary replied that the proposal for financial sanction for the digitization of reports is already submitted to the government & necessary action would be taken as soon the proposal are approved by Govt.[Action DGM]
